

Te Kotahitanga o Ngāti Tūwharetoa

## TE KŌPU Ā KANAPANAPA REPRESENTATIVE PROCESS AND NOMINATION FORM

Te Kōpu ā Kanapanapa is a permanent, joint committee of the Waikato Regional Council (WRC) and the Taupo District Council (TDC), established under the Ngāti Tūwharetoa Claims Settlement Act 2018. This committee will be made up of eight (8) members – four from Ngāti Tūwharetoa and two each from WRC and TDC.

You do not have to be a Te Kotahitanga o Ngāti Tūwharetoa (TKNT) Delegate to be nominated. However, it is crucial that nominees understand Te Kōpu ā Kanapanapa and suitable skills, knowledge and experience to fulfil the duties and responsibilities as a member.

### 1. Nomination Eligibility Criteria:

- All Ngāti Tūwharetoa members are eligible and must be aged 18 years or over.
- Nominators must consist of two persons, one of which must be a person from your hapū.
- Both nominators must be registered with TKNT.
- The application must be supported by hapū through a hapū hui.
- A cover letter summarising your motivation for the role, relevant skills, knowledge and experience of no more than two single sided A4 pages and a CV of no more than three single sided A4 pages.
- All nomination forms must be completed in full and signed by all three parties. Incomplete forms will invalidate the nomination.

### 2. Nomination Form Availability:

- In person from 130 Atirau Road, Turangi.
- Electronically, request a copy by contacting administration by email or phone.

### 3. Returning Nominations:

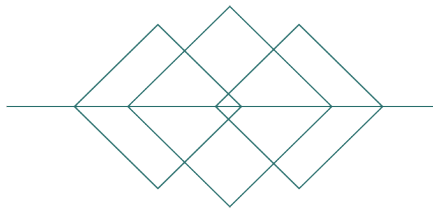
- All completed nominations (whether in person, by email or by post) must be received by TKNT no later than 5:00pm on Friday, 28 June 2019.
- All Nominees will receive confirmation that their nomination has been received.

### 4. Important Dates:

- Nominations open at 10:00am on Friday, 7 June 2019.
- Nominations close at 5:00pm on Friday, 28 June 2019.
- Nominees election at TKNT hui on Saturday, 20 July 2019.
